Town Manager's Report OCTOBER 2012

Streets:

- Staff graded and seeded along new sidewalk at 331 N. Seton Avenue.
- Staff repaired / lowered the entrance at the pool parking lot.
- Staff repainted several traffic / street striping lines
- Staff installed new speed-bump on DePaul Street.

Water:

- Rainbow Lake is at the spillway level.
- The roughing filters are being backwashed twice per day and the DE filters are being done once per week.
- Staff has flushed the Town's fire hydrants and a new water meter has been installed at Mother Seton School.
- Our wells are down an average of 6.0' from their May 2011 levels (up from 8.6' last month).
- Water production and consumption. We produced and purchased an average of 320,079 GPD. We consumed an average of 262,954 GPD.

The difference is "Backwash Water" \dots (17.8%). We purchased 433,300 gallons of water from MSM this month.

- 47.2% of this water came from wells.
- o 4.4% of this water came from Mt. St. Mary's.
- 48.4% of this water came from Rainbow Lake.

Wastewater:

- The overland flow treatment system is up and running for the season.
- During Hurricane Sandy the WWTP lost power for four days.
- We received about 9.8" of precipitation this month (the average is 3.5").
 - We have a precipitation **SURPLUS** of 5.6" over the last six months. The average precipitation for the period from May 1 thru October 31 is 23.8". We have received 29.4" for that period.
- Wastewater Treatment:
 - We treated an average of 730,000 GPD (consumed 262,954 GPD) which means that 64.0% of the wastewater treated this month was "wild water".
 - We had one spill of untreated sewerage in the month of October.

 We exceeded the plant's design capacity on seven days in the month of October.
